I also agree to be responsible for the Current Owner's reasonable attorney's fees and costs incurred by the current owner in seeking return of the animal from any third party, and collection of said liquidated damages. I also agree to notify the current owner of the animals illness or death by the same deliver methods described above.

I hereby agree to care for the above described animal in a humane and responsible manner and to provide it with clean and adequate shelter, food, water and veterinary care. I further agree that said animal shall reside in conditions of adequate shelter from the elements and shall be provided with daily sufficient exercise and shall be protected by adequate fencing and be secure from animals, dangers and implements that may cause the animal harm.

I hereby agree that this animal shall who shall be treated humanely is subject to the Current Owner's inspection at any time. Failure to provide adequate care for the animal shall result in my return of the animal to the current owner
